INSTRUCTIONS: *If you are under the age of 18*, before you can participate in the ECSC, this Consent & Waiver form must be completed, signed by you and your parent or legal guardian, and **returned to your team captain to be submitted to the ECSC**. You must also have passed a 'hunter safety course', as proscribed by your resident State laws.

Please read this form carefully as it is a legal document that can affect your rights.

In exchange for and as a condition of being allowed to participate in the ECSC, Participant and Participant's parent/legal guardian agree as follows:

1. Participant acknowledges that the ECSC features team competition skeet involving the use of firearms. Participant further acknowledges that the ECSC will emphasize safe firearm handling and shooting skills.
2. Participant understands that there are risks and dangers associated with the use of firearms, including serious bodily injury, death and property damage. Participant agrees to assume all risks, inherent or otherwise, that may occur due to, arise out of or be in connection with Participant's own participation, including without limitation the risk of serious bodily injury, death and property damage. Participant further agrees to assume all risks, inherent or otherwise, that may occur due to, arise out of or be in connection with the participation of others in the ECSC, including without limitation other competitors and audience members.

NOTE: Please be advised that it is not possible to list all of the activities and related risks that Participant may encounter by participating in the ECSC. There may be risks that are not known to Participant, or to other participants of the ECSC, and may not be foreseen or reasonably foreseeable by anyone at this time or at the time of the activities in which Participant participates. Participant agrees to assume all risks of serious bodily injury, death and property damage, and all other risks of participation in the ECSC, whether or not described to Participant.

3. Participant further covenants not to sue and agrees to release, waive, and discharge the ECSC, all members of teams shooting, the Host Club, and each of their respective directors, officers, employees, agents or volunteers (collectively, "Released Parties"), from any and all claims, demands, actions, suits, proceedings, liabilities, damages, losses, judgments and expenses (including reasonable attorney's fees and costs) that Participant may suffer, directly or indirectly, due to, arising out of or in connection with Participant's own participation or conduct (negligent or otherwise) in the ECSC or the conduct (negligent or otherwise) of other participants in the ECSC, including without limitation, the conduct (negligent or otherwise) of the Released Parties.

4. To the fullest extent allowed by law, Participant agrees to defend, indemnify and hold the ECSC, all members of teams shooting, the Host Clubs, and each of their respective directors, officers, employees, agents or volunteers, harmless from and against any and all claims, demands, actions, suits, proceedings, liabilities, damages, losses, judgments and expenses (including reasonable attorney's fees and costs) by third parties (including Participant's own family) for any bodily injury, death or property damage or other incident occurring due to, arising out of or in connection with Participant's own participation or conduct (negligent or otherwise) in the ECSC.

5. **Medical Attention:** Participant gives his/her consent to ECSC, and the Host Club to provide, through a medical staff of its choice, customary medical/athletic training attention, transportation and emergency services as warranted in the course of my participation in ECSC events.

6. Participant's signature below indicates that Participant has read and fully understands this entire Consent & Waiver, and that it shall be binding upon Participant, his representatives, heirs, assigns and next of kin.

As the parent or legal guardian of the Participant, a minor child, I affirm that I have the authority to act on behalf of the Participant and, as such, do hereby give my consent for the Participant to participate in the ECSC. I declare that I have read and fully understand this entire Consent & Waiver, and that by signing below I agree that all of the provisions of this Consent & Waiver are equally binding upon me, my representatives, heirs, assigns and next of kin, as they are upon the Participant.
